



## Partner Plan Financing 2010

### Low Cost financing starting at Prime minus 3%\*

Partner Plan Financing is a program offered by PRIDE Seeds in Alliance with Farm Credit Canada. All PRIDE® Seeds' products are eligible for Partner Plan Financing based on a minimum combined purchase of \$5000.00. To take advantage of Partner Plan Financing, confirm that your purchases will meet or exceed these minimums. After your application is approved, your order will be processed to ensure that it is shipped and available prior to planting.

Deadline for your application is April 20, 2010. Please note that your order must accompany your application. To have your seed available on a timely basis, please ensure your application is submitted and approved in advance of when you want to receive your seed. Interest charges do not begin until June 20, 2010 regardless of your purchase date, and are based on the following interest rates:

| • June 20 to December 1, 2010                 | Prime minus 3%                            |
| • <b>December 2, 2010</b> to January 31, 2011 | Prime plus 2.95%                          |
| • January 31, 2011                            | Unpaid Balance is due in full             |
| • Beginning February 1, 2011                  | 1.5% per month charge on overdue balances |

\* Note the interest rate cannot be less than zero and is based on a floating prime rate. Interest is compounded quarterly. Interest rate is subsidized by PRIDE Seeds.

If you are a **Current Customer** of PRIDE Seeds and a Partner Plan Finance participant, you will receive a letter from Farm Credit Canada continuing your credit approval for your 2010 purchase or requesting further information for review.

For **New Participants** to the Partner Plan Finance Program from PRIDE Seeds, below are the directions to complete the Partner Plan Financing application:

If you are a Sole Proprietor or Partnership and not a corporation, the following forms are required for approval:

- Loan Application Form
- Loan and Security Agreement (excluding Corporate Borrowing Resolution)
- FCC Guarantee
- Copy of Photo ID

If you are a Corporation, the following forms must be completed and submitted for approval:

- Loan Application Form
- Loan and Security Agreement (including Corporate Borrowing Resolution)
- FCC Guarantee
- Copy of Photo ID
